- 4. The Secretary and Treasurer are directed to forthwith file the duly executed Certificate of Tax Levy with the Clerk of Kane, McHenry, Cook and DeKalb County, Illinois or such person designated to receive such Certificate.
 - 5. This Resolution shall be in full force and affect forthwith its adoption.
